Our holistic approach addresses the unique and complex needs of disadvantaged youth by coordinating teams of student, family, mentor and school to ensure the success of our youth.

Denver Urban Scholars, now in its 19th year, is currently serving 177 marginalized youth (155 scholars in middle school and high school and 22 scholars in our Capstone post-secondary program).

Since its inception in 1995, Denver Urban Scholars has served over 460 youth in Denver.

TO OUR KEY STAKEHOLDERS

Denver Urban Scholars begins its 19th year of operation in a place of extraordinary growth and opportunity. What began in 1995 as a small operating foundation serving a handful of students has grown into a broadly supported public charity approaching 200 youth served each year. We have developed a network of staff, mentors, donors, and collaborators that is dedicated to improving the life prospects of marginalized Denver-area youth.

Our students are among those most at risk for dropout and delinquency. For many of our students, simply getting to school every day is a feat; keeping up in school and avoiding negative behavior requires determination and emotional support. Denver Urban Scholars identifies these higher-risk youth through our school partners and surrounds them with the resources they need to end the cycle of poverty in their families through education and positive social development.

Over the past five years, 93% of our seniors have graduated, in spite of the negative factors at work in their lives. Most of these students are the first in their families to graduate and, yet, 96% have gone on to college. We are proud of our students' accomplishments and grateful for the community support we


receive, which allows us to reach more youth each year. In the past year, we increased our number of youth served by 31% and our board and development committee worked hard to increase our income by 20% to accommodate this growth.



We now serve students middle school through high school and into two years of post-secondary education with our unique, clinical case management and mentoring model. Denver Urban Scholars is widely recognized as an effective dropout prevention program by Mile High United Way, the Colorado Department of Health & Human Services, the Office of Juvenile Justice and Delinquency Prevention, the Youth Mentoring Collaborative, and is one of a select group of nonprofits recently chosen to participate in Mile High United Way's Performance Collaborative.
